- 1. Call to order. Rolf Olsen called the meeting to order at 7:00 pm at the Broadcast Studio.
- 2. Approval of minutes March 28, 2011.

Mr. Olsen thanked two members for their years of participation on the Budget/Finance Committee Ralph Bartholomew and Will Chapman.

4. Election of chairman.

5. Discussion of new 2012-2013 Budget Schedule.
