Mr Gosselin – Last year we talked about refining the ordinance to include Vice-Chair for this committee.

Chairman Bullock – We also talked about eliminating the Superintendent of Schools as an ex officio member. It also needs to be cleaned up for gender language.

Mr Gosselin – I liked splitting up the work sessions with the Department Heads. Will we still be sending any questions for the Department Heads through you?

Chairman Bullock – Through me, please. Does anyone still want to get the GPCOG newsletter? MWAC monthly report?

Mr DesJardins – I would like to get the MWAC report.
